MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE CHILD & FAMILY DEVELOPMENTAL CENTER, INC., D/B/A HORIZON CHARTER SCHOOL OF TAMPA

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on February 6, 2023, at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mr. Donald Newberry and Mr. Tim Fannin. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., Mr. Steve Hicks, COO of LLL Licensing, Inc., and Mrs. Sheila Thomley, Principal of Horizon Charter School of Tampa. The meeting date, time, location, and agenda were publicly posted.

The minutes from the October 3, 2022, Board of Directors meeting were presented and approved, with a date correction noted.

The financial statements were reviewed for the first six months of the 2022-23 fiscal year, including the balance sheet as of December 31, 2022, showing total equity of \$196,096. The budget report was presented (showing year-to-date revenues of \$1,629,752 and expenses of \$1,703,612 and showing an amended annual budget of \$3,222,954 total revenue and \$3,222,815 total expenses). The balance sheet and budget reports, including the amended budget, were accepted. Dr. Hicks will submit the Florida Department of State 2023 Annual Report on behalf of Board Chair Barlar.

Mrs. Thomley reported qualifications and duties of all staff individually (refer to 6-page addendum "Horizon Charter School Quarterly Board Meeting February 6, 2023"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. A 2023 Spring Out-of-Field Letter will be sent. Progress monitoring was completed prior to January 31, and NWEA assessments were completed in December to provide effective in-house monitoring. 292 students are enrolled currently. A field trip to Tallahassee will take place on February 7. Horizon Charter has been awarded the designation of School of Excellence for 2022.

Grant funding, including ESSER grants, and facilities projects were discussed. The grants help to offset mental health services, textbooks, technology, salaries and possible summer school programs.

Parking lot resurfacing has been completed. Permitting for the drive lane was obtained, and the project will require significant fundraising to be completed.

The board approved the proposed calendar for the 2023-24 school year. The board approved increasing the annual activities fee from \$35 per student to \$45 per student, effective next school year.

Time was allocated for public comments, which were shared with the board.

The next board meeting is scheduled for April 24, 2023. There being no further business, the meeting was adjourned.

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on July 18, 2022 at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mr. Jonathan Barlar, Chairperson, Mrs. Sharon Wingo, Mr. Donald Newberry and Mr. Tim Fannin. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., Mr. Steve Hicks, COO of LLL Licensing, Inc., and Mrs. Sheila Thomley, Principal of Horizon Charter School of Tampa. The meeting date, time, location, and agenda were publicly posted.

The minutes from the July 18, 2022, Board of Directors meeting were presented and approved.

The 2021-22 Horizon Charter Audit Report, including the final budget, disclosed no instances of noncompliance and was accepted by the board. The audit report showed that the school improved its total net position by \$8,507 from June 30, 2021, to June 30, 2022. The financial statements were reviewed for the first month of the 2022-23 fiscal year, including the balance sheet as of July 31, 2022, showing total equity of \$191,883. The budget report was presented (showing year-to-date revenues of \$222,368 and expenses of \$300,442 and showing an annual budget of \$3,249,173 total revenue and \$3,139,756 total expenses). The balance sheet and budget reports were accepted. A certificate of deposit will be moved within Bank of America to Merrill to obtain higher interest rates.

Mrs. Thomley reported qualifications and duties of all staff individually (refer to 6-page addendum "Horizon Charter School Quarterly Board Meeting October 3, 2022"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. A 2022 Fall Out-of-Field Letter was sent out regarding five teachers. State progress monitoring was completed prior to September 30, and NWEA assessments were completed in August to provide effective in-house monitoring. 303 students are enrolled currently.

The distribution plan for A Plus funding remains the same. The Teacher Salary Increase Allocation report has been submitted. All teachers are now earning at least \$47,500.

Grant funding, including ESSER grants, and facilities projects were discussed. Doors, touchless faucets and bottle fills were installed. Locks and gutters are in process. Parking lot resurfacing is scheduled to be completed in October. Permitting for the drive lane is completed and bids are being obtained. Webb Middle School will be used for evacuation staging and reunification.

The board agreed to alter the school calendar if needed to accommodate any additional days needed to make up for closure due to Hurricane Ian.

No public items were placed on the agenda.

The next board meeting is scheduled for January 30, **2**023. There being no further business, the meeting was adjourned.


