MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS
OF THE CHILD & FAMILY DEVELOPMENTAL CENTER, INC.,
D/B/A HORIZON CHARTER SCHOOL OF TAMPA

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on July 15, 2020 at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mr. Al Kelly, Chairperson, Mrs. Sharon Wingo and Mr. Rob Smith, Jr. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., and Mrs. Sheila Thomley, Principal of Horizon Charter School of Tampa. The meeting date, time, location, and agenda were publicly posted.

The minutes from the February 3, 2020 Board of Directors meeting were presented and approved. The meeting scheduled for April 27, 2020 was canceled due to COVID-19 closure.

The financial statements were reviewed for the 2019-20 fiscal year. The year-end income and expense report through 6/30/20 was presented (showing year-to-date revenues of \$2,506,281 and expenses of \$2,504,214) along with the final budget (showing revenues of \$2,509,520 and expenses of \$2,509,191). The preliminary budget for 2020-21 (showing total revenue of \$2,591,435 and expenses of \$2,587,346) was presented. The income and expense and budget reports were accepted. The 2020-21 Capital Outlay Report has been submitted to the state.



Mrs. Thomley reported qualifications and duties of all staff individually (refer to 7-page addendum "Horizon Charter School Quarterly Board Meeting July 15, 2020"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. There were no school grades for 2019-20 due to the COVID-19 closures and cancellation of FSA testing. FSA is expected to occur in 2020-21. All Horizon Charter progress monitoring tools can be deployed over eLearning. There are 328 students enrolled thus far for 2020-21. The open houses will be conducted in three formats: drive-by, virtual and in-person.

Health, safety and security updates include CurbSmart pickup, closing the lobby to traffic, and addition of UVC lights to air handlers. Grant funds are assisting with COVID-19-related expenses and safety and security, including security privacy fencing and the Centegix security alert system. The 2020-21 Mental Health Plan was approved.

The board approved the 2020-21 Re-Opening Plan, including traditional and eLearning programs. Teacher raises are being implemented according to new statute. The annual site visit by the district has been completed and the annual audit is taking place remotely. The board approved postponing the start date for the 2020-21 school year as needed to align with the Hillsborough School District.

All board members acknowledged annual receipt of the Conflict of Interest Policy.

No public items were placed on the agenda for comments or discussion. The next board meeting is scheduled for October 5, 2020. There being no further business, the meeting was adjourned.

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on October 26, 2020 at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mr. Al Kelly, Chairperson and Mrs. Sharon Wingo. Mr. Rob Smith, Jr. joined remotely by videoconferencing. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., and Mrs. Sheila Thomley, Principal of Horizon Charter School of Tampa. The meeting date, time, location, and agenda were publicly posted.

The minutes from the July 15, 2020 Board of Directors meeting were presented and approved.

The 2019-20 Horizon Charter Audit Report disclosed no instances of noncompliance and was accepted by the board. The audit report showed that the school improved its fund balance by \$240 from June 30, 2019 to June 30, 2020. The financial statements were reviewed for the first two months of the 2020-21 fiscal year, including the balance sheet as of August 31, 2020 showing total equity of \$255,753. The budget report was presented (showing year-to-date revenues of \$434,227 and expenses of \$425,857). The balance sheet and budget report were accepted.


Mrs. Thomley reported qualifications and duties of all staff individually (refer to 7-page addendum "Horizon Charter School Quarterly Board Meeting October 26, 2020"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. The out-of-field letter was sent to parents/guardians on August 17, 2020. Traditional and eLearning are continuing for the second nine weeks, which began on October 20, 2020. All students whose families replied during the response window were accommodated for return to campus. It is anticipated that all students will return to campus in January. There are 327 students enrolled currently for 2020-21.

Health, safety and security updates, include Curb Smart pickup and closing the lobby to traffic, are working well. Grant funds continue to assist with COVID-19-related expenses and safety and security.

The completed annual site visit by the district was discussed by the board. The board discussed a private personnel issue. The RSA Consulting Group made a presentation to the board. The board approved parameters for contracting with RSA for consulting services.

The board approved revisions to the Parent-Student Contract. The board approved changes to the K-2 Pupil Progression Plan. The board approved changes to the 2020-21 school calendar.

No public items were placed on the agenda for comments or discussion. The next board meeting is scheduled for January 25, 2021. There being no further business, the meeting was adjourned.

Present were board members Mr. Al Kelly, Chairperson, Mrs. Sharon Wingo and Mr. Rob Smith, Jr. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., Mrs. Sheila Thomley, Principal of Horizon Charter School of Tampa, and Mr. Donald Newberry. The meeting date, time, location, and agenda were publicly posted.

The minutes from the October 26, 2020 and December 9, 2020 Board of Directors meetings were presented and approved.

The board voted to accept Mr. Donald Newberry as a board member, contingent upon completion of fingerprinting and board member training, at which time Mr. Smith's resignation from the board will become effective.


The financial statements were reviewed for the first six months of the 2020-21 fiscal year, including the balance sheet as of December 31, 2020 showing total equity of \$292,294. The board received financial statements for the separate Developmental Center Counseling and Evaluation activities for the 2019-20 fiscal year, showing annual revenues of \$38,408 and expenses of \$47,898 and total equity of \$140,976 as of 6/30/20.

Mrs. Thomley reported qualifications and duties of all staff individually (refer to 7-page addendum "Horizon Charter School Quarterly Board Meeting January 25, 2021"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. The out-of-field letter was sent to parents/guardians on January 25, 2021. Traditional on-campus (65%) and eLearning (35%) are continuing for the third nine weeks. Mid-year progress monitoring data was reviewed. There are 319 students enrolled currently for 2020-21. The school was licensed as a day care facility on January 6, 2021.

Grant funds continue to assist with COVID-19-related expenses and safety and security. Four grants are in progress, including perimeter and interior fencing projects.

The 2020-21 audit engagement letter was approved and signed by the board chair. The board approved the 2021-22 school calendar and approved the 2021 pupil progression plans, which are unchanged from the October 2021 board meeting.



Traditional on-campus (77%) and eLearning (23%) are continuing for the final quarter of the school year. Mid-year progress monitoring data were reviewed. 100% of students completed the FSA Writing Test. There are 317 students enrolled currently for the 2021-22 school year.

Grant funds continue to assist with COVID-19-related expenses and safety and security. Four grants are in progress, including perimeter and interior fencing projects, and two additional grants are pending. If funding is available, mental health services will be increased.

It is anticipated that all students will attend on-campus for 2021-22. The board will address the use of face masks and other 2021-22 health and safety protocols during the July board meeting.

The board approved the addition of iReady to the first and second grade pupil progression plans. The board approved staff bonuses for two administrators not included in the state bonus program for principals and teachers. The board recognized a Horizon Charter graduate who is the 2021 valedictorian for Jefferson High School. Conflict of Interest Policy acknowledgments were signed by board members.
