MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS
OF THE CHILD & FAMILY DEVELOPMENTAL CENTER, INC.,
D/B/A HORIZON CHARTER SCHOOL OF TAMPA

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on October 2, 2023, at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mrs. Sharon Wingo and Mr. Tim Fannin. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Mr. Steve Hicks, COO of LLL Licensing, Inc., Mrs. Sheila Thomley, CEO of Horizon Charter School of Tampa, and Mrs. Pamala Leonard, Principal. The meeting date, time, location, and agenda were publicly posted.

The minutes from the July 17, 2023, Board of Directors meeting were presented and approved.

The 2022-23 Horizon Charter Audit Report, including the final budget, disclosed no instances of noncompliance and was accepted by the board. The audit report showed that the school improved its total net position by \$17,974 from June 30, 2022, to June 30, 2023. The financial statements were reviewed for the first two months of the 2023-24 fiscal year, including the balance sheet as of August 31, 2023, showing total equity of \$314,030. The budget report was presented (showing year-to-date revenues of \$590,569 and expenses of \$564,467 and showing an annual budget of \$3,073,918 total revenue and \$3,061,272 total expenses). The balance sheet and budget reports were accepted.

Mrs. Leonard reported qualifications and duties of all staff individually (refer to 6-page addendum "Horizon Charter School Quarterly Board Meeting October 2, 2023"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. The Out-of-Field letter dated October 3, 2023, was satisfactory to the board. Staffing is full, and 311 students are enrolled for the 2023-24 school year.

Mrs. Thomley reported that the DAS System installation is being completed, and the final inspection with Hillsborough Fire is pending. Mrs. Thomley reported that teachers received \$300 each through the Teacher Classroom Supply Program and that TSIA funds brought the lowest teacher salary up to \$49,400, as approved by the board. Student Handbook changes and the Health, Safety and Welfare Magistrate Policy were approved by the board. The Comprehensive Reading Plan has not changed since it was previously introduced and approved by the board.

The board approved the 2023-24 Projected Goals and the 2024-25 school calendar. The board approved the plan for the school district to keep IDEA funds and provide services to Horizon Charter for the 2023-24 school year.

No public items were placed on the agenda.

The next board meeting is scheduled for January 29, 2024. There being no further business, the meeting was adjourned.

A meeting of the Board of Directors of the Child and Family Developmental Center, Inc., d/b/a Horizon Charter School of Tampa, was held on July 17, 2023, at 7235 West Hillsborough Avenue, Tampa, Florida. Present were board members Mrs. Sharon Wingo and Mr. Tim Fannin. Also present were Dr. Andrew Hicks, administrator and clinical psychologist, Dr. Eric Larson, President of LLL Licensing, Inc., Mrs. Sheila Thomley, CEO of Horizon Charter School of Tampa, and Mrs. Pamala Leonard, Principal. The meeting date, time, location, and agenda were publicly posted.

The minutes from the April 24, 2023, Board of Directors meeting were presented and approved.

Mr. Jonathan Barlar submitted his resignation to the board on July 10, 2023. The board discussed finding a new board member and establishing a new board chair.

The financial statements were reviewed for the first eleven months of the 2022-23 fiscal year, including the balance sheet as of May 31, 2023, showing total equity of \$186,782. The budget report (showing estimated year-to-date revenues through June 30, 2023, of \$3,041,320 and expenses of \$3,035,183) was presented, along with the proposed 2022-23 final budget (showing revenues of \$3,044,658 and expenses of \$3,038,336) and the 2023-24 preliminary budget (showing revenues of \$3,073,918 and expenses of \$3,061,272). The balance sheet, budget report, final budget and preliminary budget were accepted. The board accepted a \$75,000 administrative/consulting fee waiver for 2022-23.


Mrs. Leonard reported qualifications and duties of all staff individually (refer to 6-page addendum "Horizon Charter School Quarterly Board Meeting July 17, 2023"). Certifications and endorsements of all the teachers were reviewed individually and were satisfactory to the board. The Out-of-Field letter dated July 17, 2023, was satisfactory to the board. Staffing is full and 317 students are enrolled for the 2023-24 school year.

Mrs. Thomley reported that the DAS System installation is in progress. School grades are set for release in October or November. HCST earned 89% of points during the Spring FAST Assessment. Mrs. Thomley reported that all students will be provided a paper copy of the new Student Handbook. She also reported on the increased student activities plans, McKinney-Vento Act compliance, the new school website, the new uniform company, the Florida Civics and Debate Initiative, and the transfer of day care licensing from Hillsborough County to the State of Florida.

The board approved continuation of the Mental Health Plan for 2023-24 with the same format as 2022-23 and approved that the 2023-24 Reading Plan would reflect no change from the current reading implementation.

No public items were placed on the agenda.

The next board meeting is scheduled for October 2, 2023. There being no further business, the meeting was adjourned.
